This is a space rental agreement between the Dunnville Agricultural Society and the party named above hereinafter called the lessee for the Dunnville Agricultural Fair Aug.18 & 19, 2017. All lessees must be set up and ready for business by 1:00 pm on Friday, Aug. 18, 2017. Set up Friday morning—security on grounds Friday/Saturday night. Vendors responsible for supplying their own tent, table, chairs, 100 ft. extension cords (items not supplied).

**Vender spaces are all outdoors, \$100 for 10'X10' \_\_\_\_\_ and \$200 for 20'X20' \_\_\_\_\_ due on or before August 12, 2017. Please add \$35 if hydro is required (provided on Aug 18 + 19). Submit your forms early as space is limited. Payment reserves your spot.**

Two vendor passes will be issued. It is the responsibility of the leader to trade off vendor passes with workers. Vendors will be allowed to drive in and pack up if desired, starting at 8:00 pm on Saturday.

Vendors must supply their own 100 ft. extension cord. Hydro is limited, available on a first come first serve basis (spaces given to vendors who complete forms + payment).

All lessees must carry their own liability and loss of property insurance – minimum \$2 Million. **A copy of proof of insurance must be attached.**

All fees must be paid at time of registration by cheque made out to Dunnville Agricultural Society or by e-transfer to [info@dunnvillefair.ca](mailto:info@dunnvillefair.ca). **Payment is non-refundable if you are confirmed and a no show on fair weekend.**

**HOLD HARMLESS AGREEMENT:**
